General Eligibility:

10th/SSLC, PU/12th/ 3 years Diploma

Bachelor's degree in any discipline with an aggregate of a minimum of 50% marks.

Valid score in CAT/MAT/AIMA/CMAT/KMAT

Eligibility Criteria for SC/ST/CAT – I

Relaxation of 5% of minimum marks required for admission to post-graduation courses as prescribed by the government policy for scheduled caste/ scheduled tribes/ category I students of "Karnataka Students" is provided.
